### SECTION 4: FIRST-AID MEASURES

**4.1 Description of necessary measures:**

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

#### 5.1 Suitable (and unsuitable) extinguishing media:

##### Suitable extinguishing media:

Combustible liquid. If possible use polyvalent powder fire extinguishers (ABC powder), alternatively use foam or carbon dioxide extinguishers (CO<sub>2</sub>).

#### 5.2 Specific hazards arising from the chemical:

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.
