### SECTION 4: FIRST-AID MEASURES

#### 4.1 Description of necessary measures:

### SECTION 5: FIRE-FIGHTING MEASURES

#### **5.1 Suitable (and unsuitable) extinguishing media:**

##### **Suitable extinguishing media:**

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inert medium. Remove any source of ignition. Transfer in well ventilated areas, preferably through localized extraction. Fully control sources of ignition (mobile phones, sparks,...) and ventilate during cleaning operations. Avoid the existence of dangerous atmospheres inside containers, applying inertization systems where possible. Transfer at a slow speed to avoid the creation of electrostatic charges. Against the possibility of electrostatic charges: ensure a perfect equipotential connection, always use groundings, do not wear work clothes made of acrylic fibres, preferably wearing cotton clothing and conductive footwear. Comply with the essential security requirements for equipment and systems and with the minimum requirements for protecting the security and health of workers. Consult section 10 for conditions and materials that should be avoided.
